- *All rental instruments have been inspected to ensure that they are in good playing condition. If you find any defects, missing parts, you must contact us within 3 days of rental.*
- *If you choose not to purchase the optional protection option, you may be charged repair or replacement fees for damages beyond normal wear and tear.*
- *Your instrument can be returned anytime. However, there is absolutely no refund for rental payments already made. We also do not prorate for early returns.*
- *All repairs must be done by My Music Skool. Unless you purchase the Optional Protection plan, you will have the sole responsibility to pay for the cost of repair if there is damage resulting while in your possession.*
- *Protection program coverage excludes; Reeds, Mouthpieces, Valve or Slide Oil, Strings, Rosin, Shoulder Rests, Cleaning Kits/supplies, Straps and Cork Grease even if they were included with your initial rental.*
- *Smaller string instruments are traded up to larger same instruments as student grows for no extra charge.*
- *If you decide to switch instruments, you will be charged the difference (if applicable) in rental fees plus \$25 administrative fees.*
- *All instruments rented by My Music Skool shall remain the property of My Music Skool until it has been purchased by a customer. You have an option to purchase the rental instrument at any time during the lease as long as you are not in default of this contract. Contact My Music Skool for more information.*
- *If you are in default of this agreement, your arrearage and full future payments shall immediately become due. When in default, we may terminate this agreement with you and charge you for any outstanding balance plus late charge of \$20 each month. If you are still in possession of the instrument 7 days after we notify you of the termination, you will be responsible for the price of the instrument plus all other costs including the collection and legal fees associated with these actions. Return of the instrument as credit toward this obligation will no longer be accepted.*
